(The Grand Jury Court Reporter, Donald L. Ostrov, was sworn as follows:

THE FOREMAN: Do you solemnly swear that you will correctly take in shorthand and correctly transcribe, to the best of your ability, all of the testimony given by each and every witness testifying in the matters now pending before this Grand Jury, and that you will keep secret and divulge to no one any of the proceedings of this Grand Jury, so help you God?

THE REPORTER: I do.)

(At the beginning of these proceedings 22 Grand Jurors are present.)

THE FOREMAN: May we come to order, please?

Ladies and gentlemen, the name of the possible defendant, Sirhan Bishara Sirhan.

Matters to be considered in connection with the above-named possible defendant:

On June the 5th, 1968, at approximately 12:20 a.m., the suspect, Sirhan Bishara Sirhan, shot Senator Robert F. Kennedy and five other individuals,

 Paul Schrade, Irwin Stroll, William Weisel, Elizabeth Evans, and Ira Goldstein, at a gathering at the Ambassador Hotel following the primary elections.

Senator Kennedy had just completed his statement proclaiming his victory in the Democratic Primary when the shooting began.

The suspect, Sirhan Bishara Sirhan, was disarmed at the scene and taken into custody.

Senator Kennedy died at 1:44 a.m. the following morning.

Any member of the Grand Jury who has a state of mind in reference to this case or to any of the parties involved which will prevent him from acting impartially and without prejudice to the substantial rights of any of the said parties will now retire from the Jury Room.

Do we have anyone who wishes to disqualify himself?

(There being no response, all 22 Grand Jurors remain.)

THE FOREMAN: There being none, I will sign it.

We are ready, Mr. Howard.

MR. HOWARD: May we call as our first witness -- may I get him -- Paul Ziffren.

PAUL ZIFFREN,

called as a witness before the Grand Jury, was duly sworn as follows:

THE FOREMAN: Would you raise your right hand, please?

(Whereupon the witness complied with the request of the Foreman.)

Do you solemnly swear that the evidence you shall give in this matter now pending before the Grand Jury of the County of Los Angeles shall be the truth, the whole truth, and nothing but the truth, so help you God?

THE WITNESS: I do.

THE FOREMAN: Would you be seated, please, and for the record, could we have your name?

A I have known the Senator since 1956.

MR. HOWARD: That's all we have of this witness unless the Jury has occasion to direct a question.

(Whereupon the witness was excused and withdrew from the Grand Jury Suite.)

called as a witness before the Grand Jury, was duly sworn as follows:

THE FOREMAN: Would you raise your right hand, please, Doctor?

(Whereupon the witness complied with the request of the Foreman.)

Do you solemnly swear that the evidence you shall give in this matter now pending before the Grand Jury of the County of Los Angeles shall be the truth, the whole truth, and nothing but the truth, so help you God?

THE WITNESS: I do.

THE FOREMAN: Would you be seated, please, and for the record, your name?

THE WITNESS: Henry M. Cuneo.

Tuesday -- no, it was Wednesday morning. I only had two hours' sleep in about forty-2 eight hours -- but it was Wednesday morning. 8 I think it was the 5th, wasn't it? It would be June 5 then, 1968, is that Q right? Yes, that's right. Where did you first see the Senator, Doctor? In the Intensive Care Unit at the Good 10 Samaritan Hospital. 11 What was his condition at the time you Q 12 first saw him? 13 Very critical. 14 And what was the cause of the criticalness 0 15 of his condition, sir? 16 One, of course, was the intracranial 17 injury; and the other was respiratory difficulty. 18 And what procedures, if any, did you 19 undertake at that time, sir? 20 The Cardiac Service and the Chest Service 21 were doing a tracheostomy at the time I arrived to improve 22 his airway. Explain to the Grand Jury what you mean by Q 24 the tracheostomy. 25 The tracheostomy is -- an incision is π ade

in the anterior part of the neck that enters the trachea and it's -- the tracheostomy tube is then placed into the trachea so it bypasses any possible obstruction that there might be above that level from drainage of blood into the nasal pharynx and obstructing the airway.

Q The trachea, I take it -- would we say "windpipe"? Would laymen mean the windpipe, the tube that goes into the lung?

A Yes. It's the main air stem way that goes to the lungs.

Q And could you indicate upon yourself the level at which that operation was performed?

A It would be right here, above -- just below what you might call the Adam's apple.

Q After that procedure was accomplished, Doctor, what next happened?

A Well, of course, his condition markedly improved immediately following that.

There was considerable amount of blood and mucus that was aspirated through the wound and an adequate airway was maintained following that with no more respiratory difficulty.

Q By "aspirated," you mean the suction process that was going on, I take it?

A Yes.

Q Then what next was done, Doctor?

A Well, the patient was being given a fluid; he had a blood transfusion that was being started.

And after examining the Senator, he began to have some cardiac difficulties, irregularity of the heart rate.

And just before the tracheostomy had been performed, his blood pressure went up to 280, which signified increasing intracranial pressure.

Q Did you then -- or was surgery performed upon Senator Kennedy?

A Yes.

Q And how long after his admission to the hospital did you take him to surgery, sir?

A As I recall, we took him up on the surgical floor, I would estimate, around -- about a quarter to 3:00 in the morning.

Q And what was the nature of the surgery you performed upon the Senator, Doctor?

A Well, the procedure was what we call a craniotomy. It was an opening into the right posterior aspect of the skull and the removal of an adequate amount of bone to explore the area where the bullet had entered.

Q Could you point to yourself, Doctor, showing the Grand Jury where the bullet did enter?

A The bullet entered approximately in the midportion of the right mastoid process, right -- just

in back of the right ear. And for how long did you have Senator Kennedy in the surgical theater? Approximately three hours. You were assisted by other physicians, Q were you? Yes, my associate, Dr. Nat Downs Reid --R-e-i-d -- and Dr. Maxwell Andler -- A-n-d-l-e-r. What was the Senator's condition following Q the surgery, Doctor? 10 Well, he began markedly to improve, about 11 a third of the way through surgery, after some of the 12 blood had been removed, and he was able then to start 13 14 breathing on his own. 15 And although his respiratory excursions weren't maximum, he was continued to be assisted with a 16 17 positive pressure machine so that he would have -continue to have good, adequate airway, which, of course, 18 had been maintained since the tracheostomy when he had been placed in the Intensive Care Unit. 20 21 Q Subsequent to the operation, did Senator 22 Kennedy die? 23 A Yes, he did. 24 Q Were you present at the time of his death, 25 Doctor?

Yes, I was.

Did you pronounce him dead? Q 1 Yes. And at what hour did you pronounce him 0 dead? 1:44 a.m., yesterday morning. That would be the morning of June 6th, 1968? Q Yes. MR. MINER: Thank you, unless the Grand Jury has any questions, Mr. Foreman? THE FOREMAN: Does anyone have any questions he'd 10 like to ask the doctor before he is excused? 11 Doctor, it's my duty to caution you and 12 also to warn you not to discuss with anyone -- not to 18 impart to anyone any of the proceedings that were carried 14 on in this room this morning. 15 THE WITNESS: Yes. 16 THE FOREMAN: We want to thank you very much for 17 taking time out from your busy schedule to come down and 18 19 visit us. (Whereupon the witness was excused and 20 withdrew from the Grand Jury Suite.) 21 22 MR. HOWARD: May we call Dr. Noguchi as our next 23 witness? 24 25

THOMAS T. NOGUCHI,

called as a witness before the Grand Jury, was duly sworn as follows:

THE FOREMAN: Doctor, come right around here, please, Doctor. Would you stand, please, and raise your right hand?

(Whereupon the witness complied with the request of the Foreman.)

Do you solemnly swear that the evidence you shall give in this matter now pending before the Grand Jury of the County of Los Angeles shall be the truth, the whole truth, and nothing but the truth, so help you God?

THE WITNESS: I do.

THE FOREMAN: Would you be seated, please. For the record, would you give us your name?

THE WITNESS: Dr. Thomas T. Noguchi, N-o-g-u-c-h-i.

EXAMINATION

BY MR. MINER:

Q Dr. Noguchi, you are a physician and surgeon duly licensed to practice as such in the State of California?

A Yes, I am.

Q And would you tell us what position, if any, you now occupy?

A I am the Chief Medical Examiner and County

Coroner for the County of Los Angeles, sir.

Q Doctor, would you give us, briefly, a

description of your experience and history as a physician?

A I was graduated from Nippon -- N-i-p-p-o-n

Medical School in 1951. I served two-year internship; the first year was in Tokyo Imperial University Hospital and the second internship was in Orange County General Hospital.

I completed lengthy postgraduate training in Pathology, and I was appointed in 1960 as Assistant Professor of Pathology at Loma Linda University, School of Medicine, and became the Chief of the Autopsy Service, for the White Memorial Medical Center.

And I continued training in the field of forensic medicine, and I taught -- I have been teaching for many schools, including the University of Southern California, School of Medicine, as well as Loma Linda University.

And I have been engaged in medico-legal investigation for the County of Los Angeles since 1961, sir.

Q Doctor, are you certified by any specialty boards in your specialty of Pathology?

A Yes, sir.

Q What certifications do you hold, Doctor?

I am certified by the American Board of Pathology in the field of anatomical pathology.

Certification was given to me in 1960.

And then additional experience and training, and I was qualified to receive a certification in the field of clinical pathology, which was given to me in 1962; and it continues, the study in the area of medico-legal investigations and emphasis in the interpretation of the wounds and the position of the persons at the time of a shooting, and a number of medico-legal questions.

These are the sciences known as forensic medicine, and I was qualified to take the examination, and I successfully passed the examinations, and the certificate was given to me in 1963, sir.

MR. MINER: Is the Grand Jury Exhibit 4 in the hands of one of the Grand Jury members?

(Whereupon said document was handed to Mr. Miner by Mr. Howard.)

BY MR. MINER: Dr. Noguchi, I show you Grand Jury Exhibit Number 4, and ask you whether or not you performed an autopsy on the person depicted in that photograph?

Yes, I did.

Would you tell the Grand Jury, please, when and where you performed that autopsy?

The autopsy was conducted at the specially

designated autopsy room at the Hospital of the Good
Samaritan, Los Angeles, and this examination was
conducted on the date of June the 6th, 1968, and the
examination began at 3:00 a.m. and completed at 9:15
of the same date.

Q And in the post-mortem examination of the
person depicted in this photograph, would you tell us,
if you know, how this man was identified to you -that is, his name?

A By his name and also that -Q What was his name, Doctor?
A Robert Francis Kennedy, sir.

Q And did anyone assist you? Did you have any other physicians on the team assisting you with this autopsy examination?

A Yes, sir.

Q And would you tell us who they were,
please, spelling their names for the reporter, if you can?
A Yes, sir.

The assisting pathologists were John E. Holloway, M.D., Deputy Medical Examiner for the County of Los Angeles -- he is on my staff --

Q Would you spell Dr. Holloway's last name?

A H-o-1-1-a -- just a moment, please -H-o-1-1-o-w-a-y -- and another pathologist was
Dr. Abraham T. Lu, last name spelled L-u.

A

He is also deputized medical examiner for the County of Los Angeles and he is in charge of neuropathology. And Doctor, the autopsy itself was at all times under your direct supervision and control, is that correct? Absolutely, sir. And referring you to Grand Jury Exhibit Number 4, is that a picture that was taken at your direction and under your control? Yes, sir. That's the exhibit I heretofore showed you? That is true, sir. Thank you, Doctor. Doctor, as a result of your examination, did you come to an opinion as to the cause of the death of Senator Kennedy? Yes. And would you state your opinion, please? The cause of death was gunshot wound of the right mastoid, penetrating the brain. And in your examination, Doctor, did you Q determine if there was more than one wound on the body of 22 the Senator? 23

Yes.

And would you tell us how many wounds there

A total of three gunshot wounds, sir.

Q Do you mean caused by three separate bullets, Doctor?

A Yes.

Q And would you describe the location of the two, other than the one in the head?

A I'll be glad to.

May I at this time designate three
gunshot wounds as following, based on the standard
procedure, may I call this, the gunshot wound in the right
mastoid, to be Gunshot Wound Number 1, and the other two
gunshot wounds will be Gunshot Wound Number 2 and 3.

These two gunshot wounds -- before this, may I also -- the number given, purely for the purpose of identification; it does not intend to designate the time or sequence of events.

And Gunshot Wound 2 was found in the back of the right armpit, known as the right axilla; and the Gunshot Wound 2 was also found very close, approximately -- it's about half inch below the Gunshot Wound Number 2.

Q Wait a minute, I think -THE FOREMAN: He said "2" twice.

Q BY MR. MINER: Just rapidly, Doctor, so that the Grand Jury will understand that, there were two gunshot wounds in the region of the armpit, so to speak, is that right?

A Yes.

Q And that was the left or right armpit?

A Right armpit.

Q In designating them, you have arbitrarily called these gunshot wounds Number 2 and 3 as distinguished from Gunshot Wound Number 1, which was the one in the head, I take it, is that correct?

A That's correct.

Q All right. Now, as to 2 and 3, could you again tell us, they were both in the armpit and they were within half inch of each other, is that correct?

A Yes, sir.

Q Now, as to the characteristics of Gunshot Wound Number 2, could you tell us, please, what characteristics that gunshot wound had?

What was it; how did the bullet traverse in the body, if it did?

A Yes, sir. Referring to the Gunshot Wound Number 2, the entrance wound was found, as I mentioned, in the right axilla, and it penetrated subcutaneous tissue and muscle structure from right to left direction, and upward, and back to front direction.

And the exit wound was found, the front of right shoulder.

The total body x-ray disclosed there was no injury to bony structure norfragments of lead remained

in the wound track. I am referring to the Gunshot Wound
Number 2, sir.

Q Would it be correct then, Doctor, from

what you have told us, that the bullet that caused

Gunshot Wound Number 2 -
MR. MINER: Can you hear me? Is that all right?

THE GRAND JURORS: Yes.

Q BY MR. MINER: -- that Gunshot Wound Number 2 entered the body and exited from the body, and there was no part of it in the body, is that correct?

A That's correct, sir.

Q Referring you now, Doctor, to Gunshot Wound Number 3, that entrance wound was, as you told us, within half an inch of entrance wound Number 2?

A Yes.

Q Would you describe what happened to that bullet in the body?

Excuse me a moment, Doctor. Go ahead, Doctor.

A The Gunshot Wound Number 3 track was traced and it indicated the direction to be from the right to left and almost parallel to the wound, to the Gunshot Wound Number 2 pathway.

However, the wound track did not penetrate or did not penetrate the chest cavity but the bullet continued to travel the muscle structure of the back and

the bullet was found lodged in the area called the sixth cervical vertebra and slightly to the right. I wonder, Doctor, if you could designate, perhaps on me, so that the Jury could see, just where that would be? Gunshot Wound, Number 2 track was here (indicating). It was -- only it was impossible for me to trace the gunshot wound track straight unless I could place the Senator's right arm forward (witness indicating on Mr. Miner). The Gunshot Wound Track Number 3 was about this area and the bullet was lodged at midline, the lower portion of the back of the neck. MR. MINER: Thank you. (Whereupon the witness resumed his place on the witness stand.) BY MR. MINER: I take it then there was no Q exit wound for bullet wound Number 3? No, sir. Q Did you in fact recover the bullet from the location you just told us about?

A Yes.

Q And how did you recover the bullet, sir?

A I recovered the bullet by making a small standard incision from the back of the neck and gently retrived it and by my index finger.

MR. MINER: Mr. Foreman, I have here an envelope marked 5-A. May this be Grand Jury Exhibit 5-A?

THE FOREMAN: Permission granted.

Q BY MR. MINER: Doctor, I show you Grand Jury Exhibit 5-A, and I ask whether or not that --

MR. MINER: In marking that, Mr. Foreman, may the envelope and its contents be marked 5-A?

THE FOREMAN: So ordered.

Q BY MR. MINER: Is the contents of 5-A the bullet that you retrieved from Senator Kennedy's back?

Would you examine the contents, please?

A Yes. This is the bullet which I personally retrieved from the Senator Kennedy.

Q And how do you know that that is the bullet that you retrieved?

A Well, I placed my identifying mark, T.N., my initials, and last number of a Medical Examiner Coroner's Case Number 68-5731; so I placed "31," -- it is very clearly visible on the base of this bullet.

Q After you retrieved Grand Jury Exhibit 5-A from Senator Kennedy's back and you marked it as you have described, what did you do with Grand Jury Exhibit 5-A, the bullet?

A After documented, I handed it to the authorized detective who was present at the special autopsy room and the person representing was from the

Los Angeles Police Department.

Q Would you give us the name of that officer, please, or may I ask you, was that Officer or Sergeant Bill Jordan of Rampart Detectives, Los Angeles Police Department; is that correct?

A That's correct, sir.

Q At what time did you hand Grand Jury Exhibit 5-A to Sergeant Jordan?

A The bullet was recovered 8:45 a.m. on June the 6th, 1968, and I hand this bullet to Sergeant Jordan at 8:49 a.m. of the same date, sir.

Q Doctor, I take it then -- or would you tell us, do you have an opinion as to whether or not the wounds you have designated, 2 and 3, contributed to the Senator's death?

A As far as how significant they contributed, this will depend entirely upon evaluation of fatal gunshot wound.

Q Let me withdraw the question as phrased. I think it wasn't too eloquently put. I will try it this way, if I may, Doctor.

Do you have an opinion as to whether or not Wound 2 would, by itself, have been fatal?

A Unlikely.

Q And do you have an opinion as to whether Wound 3 by itself would have been fatal?

İ

A Unlikely. The term I use, "unlikely," because it causes hemorrhage and the infections and so on, and without proper medical treatment, this could cause fatal outcome.

Q But in the ordinary or usual course of events, in the treatment, proper medical treatment, you would not regard either wound as being fatal, is that correct?

A That's correct, sir.

Q Or either or both wounds in combination as likely to cause death if he was properly treated, is that correct?

A That is correct.

Q So that you would regard Wound Number 1 then as being the wound that did cause death, is that right?

A That's correct, sir.

Q And would you tell us what you found physiologically and anatomically with respect to Wound Number 1?

A The Wound Number 1 was found behind the right ear.

And the hair -- a portion of the head was previously shaven for the purpose of surgery; and there was -- a closed surgical suture was -- suture or an incision was found on the right back portion of the head.

Wound Number 1 was indeed incorporated in the area of

incision.

However, Dr. Cuneo -- I believe I have a name of the -- he was a Chief Neurosurgeon and was invited to point out area that prior surgical incision was made so that I would be absolutely certain that was the entrance wound.

And the entrance wound of the Gunshot

Q I take it that Dr. Cuneo then was present at a portion of the autopsy procedure, at any rate, was he?

Yes, sir.

Q All right. Go ahead, Doctor, please. Sorry to have interrupted.

The exact location of the gunshot wound as follows:

Three-quarter inches from the medical -medical standard landmark, which is called biauricular line, that is, line starts from right ear canal to the top of the head to the left ear canal, and different to this line.

The entrance wound was found three-quarter inch back of this line and also three-quarter inch above the ear canal, the line or horizontal line passing through the ear canal.

Then this -- the gunshot wound was also

located, measured from the top of head, which was five inches from the top of head, and at two and a half inches from the most posterior portion of the head.

Q Did the bullet -- we are talking about bullet wound, or Wound Number 1, aren't we; is that correct?

A Yes. Yes, sir.

Q Was there any external evidence of Wound Number 1 hitting the external portion of the ear before entering the skull itself?

A External ear -- as far as gunshot wound is concerned, there was no penetration of external ear, or ear lobe.

However, it was a blackening discoloration, indicating what we call powder tattooing and still grayish black powder deposited on the surface of the edge of the right ear, and this was about one inch in longest dimension.

Q Doctor, what damage to the brain, if any, was done by Bullet Wound Number 1?

A There was an extensive brain damage on the right side of the brain, mainly the brain called cerebellum, and in reference to the right lobe of the cerebellum; I should probably say "right hemisphere of the cerebellum."

There also was marked swelling of the brain as well as flattening by the pressures inside of the brain

 and causing a flattening of the brain stem.

Q And in your opinion, these events resulting from the bullet wound are the ones that caused death, is that correct?

A Yes, sir.

MR. MINER: I have no further questions of this witness, unless any member of the Grand Jury --

THE FOREMAN: Does any Juror have any question of Dr. Noguchi before he is excused? Mrs. Shalhoub?

MR. MINER: Before we look at the Grand Juror's question, Mr. Foreman, may I reopen my examination of this witness?

THE FOREMAN: Surely.

Q BY MR. MINER: Doctor, from the tattooing that you described on the edge of the ear as to bullet Wound Number 1, do you have any opinion as to what might have been the distance from which that bullet was fired?

- A Yes, I do have an opinion, sir.
- Q And what is your opinion, Doctor?

A May I -- before I would express my opinion,
I would like to qualify myself that this area may be area
called criminalistic or firearm identification, and without
having an opportunity to test the suspected firearm, using
similar cartridge and a bullet, and it will be very
difficult for forensic expert to express in a distance by
how many inches.

.

5 However, the position of the tattuoing and the powder on the edge of the right ear indicate that gunshot wound was inflicted, and I would say that the muzzle distance was a -- very, very close.

Q Do you believe this was a contact wound, that is, the muzzle was actually up against the body of Senator Kennedy?

A I would like to study further, since there are -- continuous examination must be conducted because the surgeon had removed the fragments of the skull, which may contain the powder. However --

Q Let me put it this way, can you give -- do
you have an opinion as to the maximum distance the gun
could have been from the Senator and still have left powder
burns? How is that? Can you give us an opinion on that?

A Well, yes, I think so. I can express an opinion.

Allowing a variation, I don't think it will be more than two or three inches from the edge of the right ear.

MR. MINER: I think that the question -- one question asked by a Grand Juror was answered, and the other one is:

Q Doctor were there any other pathologists

present -- and I think you have told us that Drs. Holloway

and Lu were present -- and were there some pathologists

that came from the Armed Forces Institute of Pathology in Washington who did arrive at the autopsy before it was completed? That's true, sir. Yes. Would you tell us what their names are, please? Yes. Colonel Pierre Finck, F-i-n-k. I believe that is F-i-n-c-k, Doctor. Yes, that's true. That's right --M. C. Medical Corps, United States Army. He is a Chief of Military Environmental Pathology, and the Chief of Ballistic Wound Branch of the Armed Forces Institute of Pathology. And Commander Charles Stahl, Commander in the Medical Corps, United States Navy. He is Chief of Forensic Branch in Armed Forces Institute of Pathology. And Dr. Kenneth Earle, E-a-r-1-e. He is a Chief of the Neuropathology Branch of Armed Forces Institute of Pathology. And Doctor -- or Commander Stahl's last name is spelled S-t-a-h-l, is that correct? Yes, sir. MR. MINER: I have no further questions unless the Grand Jury have some questions. THE FOREMAN: Any further questions?

Would you give us your name, please? Q 1 Irwin Stroll, I-r-w-i-n S-t-r-o-1-1. 2 Mr. Stroll, you are testifying from a Q 8 wheelchair, is that correct? Yes, it is, sir. A Will you talk as loud as you can without Q distress? Yes, I am, from a wheelchair. Now, Mr. Stroll, I'd like to direct your Q attention, if I may, to election night, June 4th, 1968, 10 and the early morning of June 5th, 1968 -- that would be 11 Wednesday morning. 12 Right. 13 Do you recall, did you go somewhere election Q 14 night? 15 Well, I went to the Ambassador Hotel, and 16 I was put in charge in guarding the door to the podium . 17 from the kitchen. 18 And I was supposed to follow the Kennedy 19 procession because I had a gift for them, and I was 20 supposed to get a signal to -- following Senator Kennedy 21 and Mrs. Kennedy -- from Stephen Smith, and the signal was 22 a nod of the head. 23 As soon as the Senator passed me to go by 24 the podium, I shook his hand and said, "Congratulations,

Senator." He said, "Thank you."

They told me the Senator would only go through like the podium door then leave through the crowd or come through the crowd and come through the podium door, and I didn't know that until ten minutes before the Senator came and we didn't know until -- what time he would come until ten minutes before he came.

And he came through, like I said, and I shook his hand, and then I saw the press coming through, after he gave his speech, but he left through the curtains behind the podium.

And then there was Jesse Unruh, Pierre Salinger, and Senator Kennedy went through the kitchen doors.

And then I saw the signal from Stephen Smith, his brother-in-law; it was a nod of the head. He said, "Come on, Irwin."

And I went through our door, the podium door, and I started going through the kitchen door when two press people pushed me away. I got in front of Mrs. Kennedy by accident.

Then we went through the door and all of a sudden the procession stopped and it was like firecrackers, just pop, pop, pop, all over the place -- and smoke -- and, well, I did this, I pushed Mrs. Kennedy -- just a reaction -- and everyone in the front turned around.

I turned around and saw Mrs. Kennedy on the

floor with Roosevelt Grier covering her. It was like a swarm of people pushing me out of the room. I went out of the podium door. I said, "God, I'm shot," and then my friends carried me off. I noted I was shot because of the blood, when the shooting started, it felt like a kick in the knee. May I interrupt you at this point. Were you in the area of the Embassy Room at the Ambassador Hotel? Yes, I was. 10 You say you were awaiting the arrival of 11 Senator Kennedy? 12 Uh-huh. 13 Roughly, about what time of night or early 14 morning are we speaking? 15 Well, I got there about 6:00 o'clock and I 16 was standing at the door from 6:00 until the assassination, 17 and the Senator didn't come in until about 12:00 o'clock. 18 At 12:00 o'clock you saw the Senator arrive? Q 19 Right. 20 Where were you located? Q 21 At --22 THE FOREMAN: There is the pointer right there. 23 BY MR. HOWARD: Just describe it, first, 24 25 can you? It was this door right there (indicating).

We have marked for an exhibit, as Exhibit 1, Q a large diagram. There has been testimony that this is a floor plan of a portion of the Embassy Room at the hotel. Do you recognize it as such? Yes, it is. And by reference to the Exhibit 1, could Q you locate with this pointer to the Jury where you were? 7 I was standing right at this door. See, the door was all the way back, and Senator Kennedy came through here. 10 I shook his hand. Then he walked up the 11 stairs and went up here. Mrs. Kennedy followed; then the press went. 12 13 Then after he made his speech, the press came through here. I was still at the door, but Senator 14 Kennedy left through the curtains, through the back, and 15 16 Mrs. Kennedy went with him. Then they went through here, and Jesse Unruh 17 and Pierre Salinger went through with Senator Kennedy --18 19 went through. Then his brother-in-law, Stephen Smith, was 20 here, and nodded, so I left my post here and I continued 21 22 to -- went through. But then two press people beat me to the 23 24 door and I went right in front of Mrs. Kennedy.

We are going a little fast for description.

First of all, I'll mark the original door that you demonstrated to the Jury as --Right here (indicating). -- as "Stroll" or "S-1," right? Q Right. Have I marked.correctly the door where you Q were when the Senator arrived? Right there. You indicated that after the Senator arrived, he walked, and you indicated -- and I will mark 10 with a pen from S-1 the general area -- am I correct --11 over to an area indicating Stage Anterpom? 12 Yes, the stage upstairs. 13 Did you remain at S-1 at that time? 14 15 They told me stay there and make sure no one 16 came through. But I noticed that the press came through 10 my door by the Senator -- there was a curtain back there --11 and he went through back here (indicating). 12 And you are indicating then an area marked Q 13 on the Exhibit 1 as Hall Ramp, is that correct? 14 Right. 15 And a double door with a curtain over it, 16 correct? 17 Uh-huh. A 18 Q And the Senator left then at this area 19 above the words "Stage Anteroom," the double door, is that 20 21 correct? Right. 22 23 Q He walked out a hallway and turned and 24 walked to his right; is that a fair statement? 25 A Right. And what occurred then?

Then the press started coming through, but we wouldn't let them through because they told us not to let any press through.

So the Senator was joined by Jesse Unruh and Pierre Salinger, and they were talking to him.

Then they all went through -- all three of them went through the kitchen door, but I remember there was a security guard standing right next to me at this door (indicating).

At S-1?

Right.

Q I am going to make a mark, continue the mark of my pen from S-1 through the curtain double door, is that correct?

A Right.

Down the hallway, and approach another Q double door. Is that your recollection --

and we got to our posts again. 1 Do you know Rafer Johnson? 2 Yes. Was he there or in the near vicinity at the Q time of the six shots? Well, I noticed that he already went into the door. He would be in the general room? Q He was in the kitchen. And Roosevelt Grier was in the kitchen? Q 10 Well, he was standing right here near Mrs. 11 Kennedy. 12 Do you recall, if you observed, did the 13 Senator stop, perhaps, to shake hands with certain people 14 on his exit through the kitchen area or the hallway to the 15 kitchen area? 16 No, I didn't. 22	Boulevard in	front of the hotel by two special officers.
23	They informed	us they were taking the injured person in
24	the Yellow Ca	b to the Central Receiving Hospital.
25	Q	Did you see a Yellow Cab at that time?
26	A	Yes.

With a person in it? Q There were a number of people in the rear 2 and the front. And what did you do at that time? Q I put out a broadcast informing Communications that the special officers had the cab and they were rolling Code 3 to the Central Receiving Hospital and with injured people. At that time did you have any idea who had Q been shot? 10 No, I did not. 11 Did you have any idea how many people had Q 12 been shot? 13 No. 14 After encountering these people, what did Q 15 you do? 16 I looked up the street, southbound, toward 17 the hotel, and I could see parking lot attendants and 18 members of the hotel staff waving to the police car. 19 To your police car? Q 20 Yes. A 21 What did you do then? Q 22 We then proceeded to their location. They 23 directed us to the front of the hotel. 24 And from there did you go somewhere? 25 Yes. 26

Where did you go? 1 A member of the staff took us in the --2 it's in the west -- southwest portion of the hotel. It's an entrance to the rear, and he took us through the passageway, up the stairs to the kitchen area. Were you on the second floor at that time? Yes, sir. A Did you see any designations of the rooms in the hotel such as the Embassy Room? 10 Not at that time. We went up the rear 11 corridors and stairs. Did you later determine that the room you 13 went to was the Embassy Room or near the Embassy Room? 14 Not to my knowledge. It was a kitchen 15 portion. I never entered any other portion of the hotel. 16 I direct your attention to the diagram . 17 which is beside you, Grand Jury Exhibit Number 1. 18 Do you recognize that diagram as the 19 location where you went? 20 Yes, I do. 21 Is that the location where you went? Q 22 I'm not really that familiar with the area 23 itself, but it was some portion of the kitchen. 24 It was a kitchen area? Q 25 Yes.

All right. And you had climbed up some Q 1 stairs coming from the ground floor? . Yes. Okay. Did you notice a number of people inside the kitchen area? Yes. Approximately how many? On my initial arrival, I -- most of the officers started up the stairs, too, and they went around 9 the right entranceway, and one of the stewards in the 10 kitchen, or whatever, he directed me that the person or 11 persons were right around his side. 12 18 So I stepped to his portion of the kitchen where he was located, and he then told me that the 14 suspect was being held in custody at that end of the room. 15 16 I -- at that time I walked over and 17 started talking to people. I couldn't determine how 18 many people were in the room. 19 There were a great number of them, but I couldn't see past the first two or three rows. 20 And did you see somebody who was designated 22 or whom you called a suspect at that location? Yes. I observed a person was being held down by -- I would say eight to ten people on top of one of the serving tables.

HOWARD: Officer, would you like to stand up 12 and go around where you can see the writing? 13 THE WITNESS: I really couldn't say unless I knew 14 where the steps were, because I don't know which is the 16 16 BY MR. FUKUTO: North is on the top of the north portion. 17 0 18 On the top? To the best of my knowledge, diagram. 19 right now, not knowing where the stairs were located, I 20 believe it would be in this area right here (indicating). 21 You are indicating one of the serving 22 tables located in the north portion of the kitchen area, 23 24 is that correct? 25 Yes. A

THE FOREMAN: Surely. Q BY MR. FUKUTO: Would you point out the general location where the suspect was at that time? The only way I have of knowing is, really, since there was two entrances, most of the officers were directed around here, and I came around here. He was on the first table right inside the door. MR. FUKUTO: I will mark that W-1. 10 I think you can take your seat again. 11 (Whereupon the witness resumed his place 12 on the witness stand.) 13 BY MR. FUKUTO: Did the suspect have a 14 weapon in his hand at the time you took custody of him? 15 He did not. 16 Did you see a weapon while you were present 17 at that location? 18 No. 19 Did you later learn that Senator Robert 20 Kennedy had been shot there at that location? 21 Yes. 22 Did you know at the time you took the 23 suspect into custody? 24 No, I did not. 25 Q Did you know who had been shot? 26

MR. FUKUTO: May I mark that W-1, Mr. Foreman?

No. You did know at least one or more -- at least one person had been shot? Yes. Did you know how many had been shot? No. So what you did was you immediately took the individual out into the patrol car and sped him away from the scene, is that correct? Yes. 10 And did you then book this individual? 11 12 I retained custody of him at Rampart Station until the detectives took custody of him. 13 Q Did you attempt in any way to interrogate 14 him while you had him in your custody? 15 Only as to his identification. 16 17 And did he give you any identification? 18 No. 19 MR. FUKUTO: Mr. Foreman, I have two photographs 20 on one board. May this be marked Grand Jury Exhibit 21 Number 3-A? Permission granted. 22 THE FOREMAN: Thank you. And I have another board MR. FUKUTO: 23 24 containing two photographs of apparently the same individual. May this be marked Grand Jury Exhibit 3-B? 25

26

THE FOREMAN: So ordered.

BY MR. FUKUTO: Officer White, I show you Q what has been marked Grand Jury Exhibit 3-A and Grand Jury Exhibit 3-B. Is that the individual that you took into custody that morning? Yes. About what time was it when you received custody of him from these eight or so individuals? I would say right approximately at 12:30 10 a.m. --11 So that was about --12 -- to 12:35 a.m. 13 About how many minutes after you arrived at that general location? 14 15 I would say within five. And within how many minutes was he away 16 from the location there at the Ambassador Hotel? 17 I would say maybe another five to get him 18 out of the hotel into the police car. 19 20 Were there a number of people in the area? 21 Yes. 22 Was there any commotion? 23 Yes, a great deal. 24 Did you have to make an effort to keep the 25 crowd away from the individual that you took into custody? 26 Yes.

Were there other police units on the scene Q at the time you first arrived? No, sir. We were the first unit. You were the first unit to arrive? A Yes. Before you took the individual into custody -Q depicted in Grand Jury Exhibit 3-A and 3-B -- had other 7 police units arrived? Yes. About how many, as far as you know? Q 10 I believe there were three to four that had 11 arrived right after we stopped at the front of the hotel. 12 These were the people that followed us up 13 the stairs. 14 While you were in the kitchen area or at the 15 hotel itself, did you see any individual that appeared to 16 be injured? 17 No, I did not. 18 Did you later either through newscasts or 19 through the papers find out the name of the individual that 20 you took into custody? 21 It was the next day, before I got off duty, 22 they had found his identity. 23 And you have heard him referred to as 24 Sirhan Sirhan, is that correct? 25

Yes.

We are talking about that incident? Yes. Could you just describe in numbers approximately how many people were in the kitchen area at the time you took this individual into custody from these other people? I would say approximately between seventyfive to a hundred. And about how large is that area? Q It's -- in the immediate kitchen area, 10 it's, I'd say, approximately a hundred feet long and 11 twenty-five feet wide, somewhere in that neighborhood. 12 And was the group of individuals acting 13 in an orderly manner? 14 No, they were not. 15 It was quite confused at that time, is Q 16 that correct? 17 Yes, sir. 18 Had any ambulances arrived at the scene at Q 19 the time you took the person into custody? 20 No, not to my knowledge. 21 And at the time you left, had any -- up to 22 that time, had any ambulances arrived at that location? 23 No. A 24 And you feel that you preceded the 25 ambulances to the scene? 26

A I thought I had then, but later I found out I hadn't.

Q An ambulance had been there and had already taken away some individual, is that correct?

A Yes.

MR. FUKUTO: I believe that's all I have, Mr. Foreman.

THE FOREMAN: Do any of the Jurors have a question of Officer White? Do you have one, Mrs. Lensing?

A GRAND JUROR: Yes.

Q BY MR. FUKUTO: When you took the suspect -- I think we can refer to him, just for the purpose of expedition, as Sirhan -- when you took Sirhan to the patrol car, was it just you and your partner Placencia escorting him to the car and placing him into the car?

A No, sir. On the initial decision to get him out of the building as fast as possible, by that time probably one or possibly two other police officers had worked their way through the crowd to my position.

And at this time they were helping us get the people off of him in order to take him into custody.

Q Did it appear to you that the people were trying to get to him perhaps to take some action against him?

A Yes. All the time they were striking at

him and trying to tear his clothing and everything. These were not police officers that were doing that? No, they were not. And the police officers were trying to Q protect the individual, is that correct? Yes. And then after you got Sirhan into the patrol car, how many people were in the patrol car when it went to the station? 10 Four. 11 Who were the people? 12 It was my partner, Jesse Unruh, and the 13 suspect and myself. 14 I see. I suppose your partner or yourself 15 Q sat with the suspect in the back seat? 16 17 Yes. Had he been handcuffed at any time? 18 0 Yes, directly after gaining control of him 19 from the people that were holding him, we handcuffed him 20 21 at the scene in the kitchen. Did he struggle with you as you handcuffed 22 0 him or as you took him into custody? 23 No, he did not. 24 And then who did you say was in the back 25 seat with him? 26

THE FOREMAN: The answer is, "Yes."

Would you be seated, please, and into the microphone, give us your name. Talk right into the microphone.

THE WITNESS: My name is Jesus Perez.

THE FOREMAN: Jesus Perez.

THE FOREMAN: Would you stand right there, please, and raise your right hand?

(Whereupon the witness complied with the request of the Foreman.)

Do you solemnly swear that the evidence you shall give in this matter now pending before the Grand Jury of the County of Los Angeles shall be the truth, the whole truth, and nothing but the truth, so help you God?

THE WITNESS: I do.

THE FOREMAN: Would you be seated, please. For the record, would you give us your name?

THE WITNESS: Vincent Thomas Di Pierro.

EXAMINATION

BY MR. HOWARD:

Q Would you spell your last name for the record?

A D-i capital P-i-e-r-r-o.

Q Will you talk as loud as you can and talk into the microphone? May we ask your business or

occupation? I am a student and work part-time at the Ambassador Hotel as a waiter. Is your father also employed there? Yes. He is the maitre d'. And I'd like to direct your attention, if I may, to the election, June 4th, 1968; did you have occasion to work or go to the Ambassador? I had occasion to go to the hotel. Did your father call you up? Q 10 Yes, he did. 11 Did he tell you, in effect, that the 12 Senator was there? 13 Yes, sir, he did. 14 A Did you desire to see the Senator? Q · 15 Yes. I was hoping I'd meet him. 16 What did you do? 17 Q At 11:15 my father called me and I told him 18 I'd be there in about twenty-five, thirty minutes. 19 And I arrived at the hotel at about twenty-20 five minutes to 12:00. 21 I arrived downstairs in the Ambassador 22 Ballroom which is directly underneath the Embassy Room, 23 and I talked with one of the waiters. 24 And I asked if he had seen my father; and 25

he said he was upstairs.

So I went through the service entrance, 1 through the kitchen -- through where they wash the dishes, actually, upstairs to the Embassy Room. Could we stop right there? Q Yes, sir. What floor is the Embassy Room on? It would be the main floor. It's the same floor that the Cocoanut Grove is on. 8 When you say "the main floor," there are Q 9 other areas though? 10 There is another area below it. 11 Have you been around that hotel some time? Q 12 You are familiar with it? 13 Yes, sir, very familiar. 14 And both from working there and because your 0 15 dad is there? 16 17 Yes, sir. And you went then up to the area of the 18 Embassy Room, is that correct? 19 Yes, sir, I did. 20 Would you go like I went or would you go 21 through like the back way? 22 I went through the back ways to avoid the 23 security people as well as, you know, the crowd, because 24 nobody could get through there unless they were an 25 employee.

	Q At the time you arrived there the
2	Embassy Room is kind of like a big ballroom?
	A It's the biggest ballroom we have.
	Q Lot of people in it?

Yes. North is to the top. Would you recognize that as a schematic drawing of the Embassy Room or a portion of the service rooms in connection with the Embassy Room? Yes, sir. Q Will you talk as loud as you can? Yes, yes. Where is the ballroom on that general 10 diagram? The ballroom goes from -- it would be over 11 here. It's right about here. This would be the wall 12 13 because these are the two swinging doors; the service 14 entrance is right near the rest room. The rest room is located here, which is not 15 16 shown on the diagram. 17 From here to - which is not extended on 18 the diagram -- is the whole Embassy Room. 19 Then if that was -- the diagram was 20 correct --21 It's correct as it can be. 22 That is correct as to an area then of the 23 Embassy Room? 24 Yes, sir, it is. 25 Now, the area shown, is that called a

kitchen, a pantry -- some name to it?

Well, this -- in this area here is the pantry. That is the area to the left portion of our diagram, is that correct? Yes, sir, it is. Would you take a pen and write "Pantry" there for me? (Witness complies.) Now, immediately to the right, toward the center of the diagram, there appears to be swinging double 10 doors going into a secondary --11 Yes, sir. 12 -- room, is that correct? Q 18 Yes. 14 Is there a name that we could call that? 15 We have a pantry now. What is that? 16 I really could not state. That's our --17 when we get all the dishes set up, the tables -- there is 18 19 no set thing. It's just the kitchen. It's part of the kitchen? 20 Q 21 It's part of the kitchen. Racks of dishes? 22 Q Yes, racks of dishes -- as they say here 23 on the "Shelves." 24 Going straight over to our right then, Q 25 there seems to be a larger area with certain -- like 26

ice machines. It's an ice machine, yes. What is that? There's two -- there is three doors that open up. It's an automatic ice machine that we use. But looking at that diagram, would that fairly depict the scene of the election night or the morning or early morning thereafter? Yes, quite obvious. 10 At the top there appear to be serving tables. Would you describe that? 11 12 This table? 18 Yes. First, it says "Table." 14 This table here is where most of the 15 silverware is usually stored. We have boxes of silverware 16 which we just, you know, grab, to set up the tables with. 17 This cabinet is used for storage, and on 18 top they have the number stands, and this screen was set up so that the people, you know, wouldn't see this. 19 That's what the screen is doing there. That's what the 20 21 screen was doing there that night. 22 Going over further to the right, there at 23 the top of the diagram, there appear to be three other 24 serving tables.

Yes.

What are those?

25

Those are where they keep the hot plates, plates warm, or the food; it's the heaters. About how high are they? They are about four feet, I'd say. In other words, if you are serving a banquet, you stick the food, or you place the food in there? That's where the food is kept, to be kept When we get it, the tray is hot. Will you show us on the diagram --10 THE FOREMAN: He has the pen. 11 MR. HOWARD: You have my pen. You have a red? 12 18 Perhaps we can use the color red. A GRAND JUROR: Here is a red one. 14 15 MR. HOWARD: Thank you, sir. Using the color red, would you show us where 16 17 you went? You told us you went -- you came in and made 18 a turn at the ice machine. 19 Will you locate and tell us as you do, your 20 path; describe it on the diagram? 21 Well, when I first entered --As loud as you can. Q When I first entered the room, I -- there 24 is stairs over here. 25 Just "Stairs," yes. Q

(Whereupon the witness complied by marking the diagram.) THE WITNESS: The stairs, to come up from the Ambassador Ballroom, from where they wash the dishes, and I -- do you want me to just draw a line? Q BY MR. HOWARD: Fine, would you? From here I proceeded this way through this door here. Q Right. Now, from here --10 That's a door we have already marked S-2, Q 11 is that right? 12 13 Yes. You went through S-2? 14 Okay. And then I took position -- I went 15 through this door here right to the entrance, and I 16 17 conversed with another fellow waiter and I asked if he had seen my father at that time, and my father walked into the room at that time. Would you mark that door, D-1, please? 20 (Whereupon the witness complied with the 21 22 request of Mr. Howard.) You talked to a chap there and --23 Q 24 Yes. -- and inquired of your father? 25 Q Did you see the party or the Senator at that 26

time? The Senator had not come down yet? What is your best recollection as to the Q time or approximate time? I would say -- well, the last time I looked at my watch was maybe a few minutes before 12:00. And by the time he came down, I suppose a few minutes had elapsed. So it would be around 12:00 or a few minutes after 12:00. 10 After your conversation at D-1, what did 11 you do? 12 I moved over to where you have marked S-1, 13 which I went from here to this door here, and I stayed 14 here until the Senator arrived. 15 Did you talk to perhaps a young man there? 16 The same waiter, he just moved over with me. 17 Was there a young chap there though at that Q 18 time like a guard or --19 Yes, he had glasses. I recall he was 20 wearing glasses, dark rimmed glasses. 21 Did you talk to him by any chance? Q 22 Yes. 23 I said, "Is there any way I can help? 24 am with the hotel." 25 And I was dressed, and he didn't think so

that I was with the hotel. But then finally, when the Senator came, he asked if I would help hold the people back, and I, you know, I helped them do that. How did the Senator come in to the platform Q for his -- we will call it his acceptance speech? He came from -- when I saw him, I saw him 7 I had moved over to about here. from here. 8 Will you put D-2 to where you went to? To here (indicating). There was very many people in this area, and I would say thirty, forty people 10 11 in that area. These were other 12 You know the employees. Q 13 than employees? Yes, these were other than employees, just 14 15 people that were there at the time. When I saw him coming from here, I moved 16 17 back to my stationary position. 18 Back to --19 This position here, by S-1. And at that time I proceeded to hold the 20 21 people back. And as the Senator came by, I shook hands 22 with him, and he then proceeded to go up onto the podium. 23 And is that where the speech and the 24 25 comments took place?

26

Yes, sir, it did. About how long did that last? As near as I can figure, between ten and fifteen minutes. You stayed in the general area of the pantry, Q at S-1? I stayed at S-1 the whole time of the speech. Q What happened when the Senator completed his talk? Mr. Minasian was down there, and at the last 10 moment he decided -- or I don't know who decided, actually 11 but he told me that they were going to take him behind the 12 stage into the Conference Room -- they wanted to hold a 13 press meeting -- instead of bringing him directly down-14 stairs. 15 What happened? Q 16 They proceeded to take him from the podium 17 behind through the stage room, through this door -- there 18 is actually no door -- it's just an opening. 19 Were there curtains there, do you recall? 20 I don't recall. 21 He went into the hall and down this incline. 22 23 Q There is a ramp there? Well, it's just a little bit of an incline, 24 25 and he walked through here.

At that moment I walked from the door to the

Senator's side.

O That's Senator Kennedy's side?

A Yes.

And I got as close as I could possibly get, which was maybe three feet, and I walked with him up to here, up to the S-2, up to the swinging doors.

Q Right.

A This door at the time was pushed open.

As I went through, I pushed this door inwardly.

This one was pushed this way.

Q The upper door was --

A The upper door was against the cabinets.

There are cabinets here, which are not shown.

And this door does not open inwardly; it opens outwardly, if you are coming that way, so this door opens going to the inside of the kitchen.

I walked through this door past -- there was a bunch of people.

And at that time I got separated from the Senator, from Senator Kennedy by about five feet, and I walked with him up to the ice machine.

And it was there that I noticed there was a girl and the accused person standing on what is -- what we call a tray stacker, where we had all the trays.

Q Would you take and indicate to the Jury the ice machine we are referring to?

I was within five feet again. 14 15 Q At the time you were at D-3, did you notice a certain individual in the area? 16 17 Yes, sir, two people I noticed. 18 or not the second person was involved, I don't know. 19 First of all, did you notice a male? A He kind of went around Mr. Uecker, and he -from here -- he looked like -- though he pulled his hand

What did he do?

Four feet -- four to six feet.

And when he stuck the gun, he looked like he was on his tiptoes because he wasn't that tall. Mr. Uecker is quite huge, and he tried to get Mr. Uecker out of the way, and he shot him. How close to the Senator were you at the time of the first shot? The same amount of distance, five feet. Q And how many shots were fired? I heard five distinct shots. I could swear to five, but --10 Could there have been more? 11 12 There could have been. I don't know if the confusion -- I was standing behind there -- the next thing 13 I knew, I had blood all over my face and my glasses. 14 15 And then the man that got shot in the head 16 fell in my arms. 17 And then the other boy that got shot in the 18 thigh, he fell on top of me, and they pushed me down, they fell on top of me. 19 Did you see what happened to the Senator before 20 you went down? 21 He was on his way, falling -- he was falling 22 23 down. He was kind of on an angle. He was just about to shake hands.

Q You say someone was shot in the head. Do you know that person by name?

A No, sir. According to the papers, the . first name is Paul. I don't know his last name.

Q You wouldn't know it? Would you describe him by size? Did he appear to be quite large?

A Yes, sir, he was, and --

MR. HOWARD: May I approach the witness --

THE FOREMAN: Go right ahead.

MR. HOWARD: -- Mr. Foreman? May we mark, with the Foreman's permission, as Grand Jury Exhibit 9, a photograph of a patient in the hospital?

Permission granted. THE FOREMAN: 1 BY MR. HOWARD: I'd like to show you Grand Q Jury Exhibit 9, if I can. Are you familiar with the person depicted 5 in that photograph? Yes. It looks like --Does this appear to be the person that you 7 have identified by a first name and as a heavy set individual, to your knowledge, shot in the head --9 10 Yes, sir. -- and fell upon you? 11 Will you return to your seat, please? 12 (Whereupon the witness complied with the 13 14 request of Mr. Howard.) As near as you can, will you recall for 15 the Jury the events immediately after the shooting? What 16 17 happened? How did the crowd react, what you saw, and 18 with particular reference to the person identified as in 19 3-A and 3-B? 20 Well, the suspect turned almost immediately; 21 and after all the shots were fired, he was trying to 22 escape. 23 He tried very,

He was trying to escape.

But Mr. Rafer Johnson -- and by this time

very hard to get away.

Mr. Grier and Mr. Uecker were all holding him against the heater. It's the stainless steel table.

They were either news reporters or representatives from the Kennedy people that were there or were friends of the reporters that somehow had gotten in with them at the time people were coming, before the Senator had come down.

People were flowing through there freely.

They were allowed to pass freely because no one knew the time the Senator was coming until about five minutes before.

Q When you came in, as you indicated, through the back or service area, was there a guard there?

A I had to pass the guard by the door. He tried to stop me.

And then one of the waiters recognized me and he said, "It's all right. He is with the hotel."

Q So there was some type of control?

A Yes, sir, there was.

Q Internal?

A Yes.

Q But from your observation, was it effective? Was the area kept clear of people?

A No. It was congested with people.

He is also an assistant to my father. 8 Did you tell anyone the Senator was coming Q in? 7 No, sir, I didn't. MR. HOWARD: Thank you. THE FOREMAN: That will be all. Thank you very 10 much. 11 (Whereupon the witness was excused and 12 withdrew from the Grand Jury Suite.) 13 14 MR. HOWARD: Ira Goldstein. 15 16 IRA GOLDSTEIN, 17 called as a witness before the Grand Jury, was duly sworn 18 as follows: 19 THE FOREMAN: Would you stand right there, please, 20 and raise your right hand? 21 (Whereupon the witness complied with the 22 request of the Foreman.) Do you solemnly swear that the testimony 23 you are about to give in this matter pending before the 24 25 Grand Jury of the County of Los Angeles shall be the 26

truth, the whole truth, and nothing but the truth, so help you God? THE WITNESS: I do. THE FOREMAN: Would you be seated, please. For the record -- pull your chair just a little forward -- for the record, would you give us your name? THE WITNESS: Yes. My name is Ira Goldstein. EXAMINATION BY MR. HOWARD: 10 Q Can you hear me all right, Mr. Goldstein? 12 Yes. 18 Q If you get in any distress or pain, will 14 you tell us? 15 No, I feel fine. 16 Q Will you tell us your age? 17 A I am nineteen and a half. 18 Q Your business or occupation? 19 A I am a news reporter for Continental News. 20 May I direct your attention to election 21 evening and the early morning of July 5th. That would be 22 Tuesday night -- I'm sorry -- June 4th and June 5th. 23 Were you at the Ambassador Hotel? 24 Yes, I was. 25 Were you there at the -- we will call it

the Kennedy celebration?

Yes. Q And did the Senator arrive? The Senator arrived around 12:00 o'clock to make a speech. He was in the hotel at the time, but he didn't come on to the Embassy Room until about 12:00 o'clock. I looked at my watch. Are we talking about the area of the Embassy Room, is that correct? This was the podium that was set up 10 for his television broadcast. 11 And he arrived and did address his following 12 there, is that correct -- a correct statement? 13 Yes, right. Where were you at the time of the address? 15 At the time of the address, I was walking 16 around, looking at a monitor. I stood on a table for a few 17 minutes, trying to see if I could see him. 18 And then someone mentioned that there was 19 sandwiches in the kitchen for the press, so I hadn't had 20 dinner, so I walked into the kitchen to see if I could find them. 22 I walked to the end of the kitchen and 23 I didn't see anything. 24 In fact, I didn't even see this man here 25 (indicating). 26

So I started walking back, and all of a sudden, the Senator started walking through. 2 So you tried to see him in the ballroom and missed him, and you saw him coming into the kitchen? Completely by accident. I didn't expect him to be coming through that soon. Was the Senator coming towards you? He was walking towards me, yes. Did you perhaps do something at this time or attempt to go up and shake his hand? 10 Well, we were walking by him. This young 11 lady I was with, she shaked his hand. The Senator's 12 eyebrows kind of raised when he saw her. 13 I was about to shake his hand, but he was 14 moving too fast, so he just passed by. 15 He passed by? You were going in opposite 16 0 17 directions? We were walking towards each other. 18 Q And you passed him? 19 A Yes. 20 What occurred next? Q 21 Well, about five or ten seconds after I 22 passed him, I started hearing gunshots. 23 At first, I thought they were balloons just 24 popping. There were a lot of balloons around. 25 About the second or third shot, I realized

that he was being shot at -- someone was being shot at. Q Did you turn around at this time? I never once turned around. 0 What did you do? I moved sharply to the left. I had stepped over Irwin Stroll, who was just hit. He was laying on the ground, bleeding. I stepped over him and moved to the left. What occurred next? 10 Next, I was just barely skinned by a bulletby the way, my pants were in the other room, my slacks I 11 was wearing-;-and I was just barely skinned by the third 12 13 or fourth bullet. I could feel the air go through. It didn't hit me. 15 16 Then, the fifth or sixth bullet did make 17 contact. Q Were you struck by a bullet? 18 Yes. 19 Where, sir? In the left thigh. And did you receive medical treatment for 22 that? 23 Yes, I did. 24 Before we go into that, how many explosions 25 or shots or sounds did you hear? 26

A minimum of five. I can't --Could there have been more? Yes, I know there were more. But you can recall at least --I can recall at least five. After you heard these five shots, did you Q happen to turn around and see the Senator or what occurred? 7 I never did. By the way, the shots had the same tone to them. 10 I don't think they were from two gums, two 11 different guns. 12 At least, they sounded ---Q 18 They sounded the same, yes. 14 The sequence of shots, how long did it last, 15 a minute, a half minute, seconds? 16 Fifteen seconds at the most. Oh, you want 17 to know what happened after? 18 Q Right. 19 Well, I kind of -- this last person that 20 was in here, he told me that, you know, I leaned against 21 his shoulders or something and I did fall against a wall, 22 I did crash into a wall. Then I staggered over to a chair that was 24 facing the opposite way -- in other words, the way the 25

26

Senator came in.

And the first thing I said was, "How is Senator Kennedy? What happened to him?" And this woman walked by, and she said to me, "How dare you talk about my husband that way," and she slapped me across the face. And I said, "I am sorry, lady, but I was I'd like to know how the Senator was -- " or shot, too. " -- is." And she said, "Oh, I am sorry, Honey," and kissed me. This was Mrs. Ethel Kennedy. 10 At that time she was not in tears. She was 11 a little hysterical though, but she wasn't crying. 12 Did you remain in that chair until you were 13 taken for medical treatment? 14 Yes, I did, and that took about ten minutes. 15 Did you see some police officers arrive? 16 I didn't see a police officer until I was 17 wheeled out of the hotel. 18 19 Did you hear sounds of struggling behind 20 you? There was a lot of confusion, that's about 21 all I heard. 22 Now, the fellow you fell against, was he 23 the chap that we brought in here on the wheelchair? 24 Yes. I fell against him and I knocked him 25 to the floor. 26

Will you describe what she had on? Q She had a white dress on, kind of short, 2 lacey -- I believe, white stockings. 8 What color hair? Q Brown. She was sitting outside, by the way. The Senator fell against her and got some blood on her dress and on her face. She was the young lady that shook his hand. MR. HOWARD: Thank you very much. 10 THE FOREMAN: There being no further questions, I 11 must caution and also warn you not to impart to anyone or 12 discuss with anyone any of the proceedings that went on 13 here in this Jury Room this morning. 14 THE WITNESS: I understand it, yes. 15 THE FOREMAN: Thank you very much for coming in. 16 Thank you. THE WITNESS: 17 THE FOREMAN: I hope we haven't tired you too much. 18 THE WITNESS: Okay. 19 THE FOREMAN: Watch the step down. 20 (Whereupon the witness was excused and 21 withdrew from the Grand Jury Suite.) 22 23 Let's take a five-minute recess. THE FOREMAN: 24 25 (SHORT RECESS.) 26

. THE FOREMAN: Would you raise your right hand, please, sir?

> THE WITNESS: Yes.

THE FOREMAN: Would you be seated, please, and for the record, would you give us your name?

THE WITNESS: My name is Arthur Placencia.

EXAMINATION

BY MR. HOWARD:

What is your business or occupation? Q

I am a police officer for the City of Los Angeles, working out of the Rampart Patrol.

it be like an office area? A kitchen area. Q Kitchen area. Did there seem to be some excitement going on in that kitchen area? A Yes, quite a bit. And you had received a report, had you not, there had been some type of trouble. What information did you have upon your arrival in that kitchen? 10 Well, all we knew was what came out of the radio, that came out, an ambulance, shooting, man down, 11 3400 Wilshire, so we responded to the call. 12 13 And when we got there, we got off the car, and then people started directing us and telling us, "He 14 is over here, he is over here -- the man that shot him is 15 16 over here." 17 So we just started following people up this 18 kitchen area and that's --19 You finally arrived at a location within Q 20 the kitchen. 21 Did you see some type of struggle going on or occurring? 22 23 Yes, sir. When we got up to this area where we got the suspect, there were people holding this suspect 24 down on top of this sheet metal table, I guess you could 25

say.

Q That suspect is the person identified in, 1 shown --2 8 Yes, sir. -- in Exhibits 3 before you, is that correct? Yes, sir. Were there a lot of people or more than one person holding this suspect? Yes, sir. There was -- well, I couldn't exactly tell you how many. 10 There was quite a few. I remember one 11 distinctly of --12 18 Pretty big, large fellow? 14 Colored guy. It turned out later to be Rosie Grier. 15 16 Q When you saw this happening, were you apprehensive about the safety of the person? 17 18 That was the first thing we thought of. We seen all the people around there. We knew we'd have 19 to get him out fast. 20 21 What did you do? Did you take one of them off? 22 Yes, I took Rosie Grier off. 23 A Don't laugh. It wasn't funny. 24 25 And your partner, White, did he take someone Q off? 26

He took two persons. One had him in an arm strangle, and another person, which turned out to 2 be Rafer Johnson, grabbed him from the arms, I think. 3 And he took him off, and we got him off the table. We cuffed him --Б Were you in a police uniform --Q Yes, sir. 7 -- telling everyone you were taking him Q into custody? We had to keep telling 'em, 'We are police, 10 step aside." 11 And after a while we got tired telling 12 them. We just started pushing. 13 We got the suspect off the table and 14 handcuffed him and proceeded to take him out. 15 Now, after you took the person into custody, Q 16 did you attempt to get him out of the location as quickly 17 Is that a fair statement? as you could? 18 A Yes. 19 Well, like I said, we knew we had to get him 20 out there fast because everybody was hollering, you know, 21 "He did it. He is the one that shot him." 22 We didn't know who he had shot. We just 23 knew he had shot somebody. 24 All we knew was that he was a suspect. 25 Knowing, when you left, there were other Q 26

officers arriving, and arriving in response, also? Yes, because when we were driving into the big driveway, we were talking to the taxicab driver that was taking other people, I guess, gotten injured, and another patrol car came in right behind us. And I seen about three or four about half a block away, so when we ran in, I remember there was only four of us that ran in there, four police officers. Now, after, did anyone go with you, if you recall, from the area of the hotel to the station? 10 Yes. 11 12 Q Do you know who that person was? Jesse Unruh, I think. 14 Q The person identified as Jesse Unruh? 15 Yes. 16 Q Was there some reason he went with you? 17 Did he say something? 18 What do you mean, "Did he say something"? You mean why he thought he should go? 19 20 No, he just was tagging along, I guess. 21 We never asked him to come. He had ahold 22 of the suspect. 23 My partner had him from the right, from my partner's right, and the suspect's left, and Unruh was on 24

the other side -- kept hollering, "We don't want another

Oswald, we don't want another Oswald."

Q With those remarks, did that indicate to you the subject of the shooting? I wasn't thinking about who he had sl No. I was just thinking of getting him out of there because these people were -- were, like I say, were really -- looked to me like they were really out to get him. Now, after, you took the subject in the pictures into custody to the station, is that a fair 10 statement? 11 Yes, sir. 12 Did you keep him in your custody for a 13 period of time? 14 Well, we had him in our custody from the time we got him off the table all the way until we got to 15 16 Rampart Station. 17 Was he handcuffed at that time? 18 A Yes, sir, all the time. 19 Now, upon your arrival, or during, perhaps, the trip, did you attempt to locate the name or ask this 20 21 person his name? 22 The suspect's name? 23 Q Yes. 24 Yes, I asked him, you know, "What is your 25 name?" 28 And he wouldn't say anything.

Cause I knew I was going to have to make a report on him, I asked him, just like any other suspect, I asked him, "What is your name?" 3 He didn't say anything. Would he communicate at all with you on the 0 ride to the station? Well, when I was giving him -- Travis turned around, my partner, White, and told me, "You better give him his rights, Partner." For the subject -- or the suspect, of his 10 constitutional rights? 11 Yes. So I took out my officer's Field 12 Notebook, and I started reading off the rights. 18 And after I read them off, I asked him, 14 "Do you understand your rights?" 15 And he looked at me, and I asked him again; and then he mumbled something. 17 18 So I told him, "Look, I will give them to 19 you again." So I read them off again. Then I asked 20 him again, "Do you understand your rights?" 21 Then he looked at me and said, "Yes." 22 And then I said, "Do you wish to remain silent?" And he just didn't say anything. Then he looked at me again and he said,

"Yes." 1 Then I said, "Do you wish an attorney 2 present?" 3 Then at that time he just said, "Yes." So after that I didn't ask him any more. And then, after that, I asked Jesse Unruh, I said, "By the way, who did he shoot?" 7 And he goes, "Bobby Kennedy." And I said, "Oh." Then I looked at him and I go, "By the way, 10 who are you?" 11 12 He goes, "Jesse Unruh." I said, "Oh," so we just kept going to the 13 station. 14 Upon your arrival at the station, is it customary to search or make a search of a person in 16 custody like this individual was? 18 Well, it's customary to search him before we usually handcuff him. 19 20 At that time I didn't think it was right to do it there, so as soon as we got to the station we 21 took him into the Interrogation Room and we emptied all 23 his pockets. 24 And is it customary to make police reports 25 of what you find? 26 Yes, sir.

Q Can you recall what you found when you emptied the pockets of the subject?

A We found four \$100.00 bills, I think one \$5.00 bill, four \$1.00 bills, some change, paper clipping two paper clippings, and a key, two unused .22 bullets, one -- then there was one with the head of the bullet -- I don't know what you call it, and he had a white sheet there, some kind of a Kennedy yell -- I guess it was their yell for that night -- and then he had a key.

I think that's about all he had.

Q You took those into your possession, is that correct?

A Yes, my partner and I did.

Q Were these items booked into evidence?

A Yes.

HOWARD: May I direct your attention to Grand Jury Exhibit 10 and 11. Would you examine those? First of all, 10 being what appears to be a typewritten piece of paper containing -- is that --8 Yes. Q Is that what you said was a cheer co --10 Yes. 11 12 Did you take that from the possession of the suspect after his arrest and upon his search? 13 Well, when we searched him, this was -- he 14 had -- Officer White is the one that marked it. 15 16 Q But you were there? 17 Yes, we marked -- I seen him mark it. 18 Q May I show you 11. We took him straight out through these hall doors which was, now, I guess, the Colonial Room, and from the Colonial Room --

Do you want to know which way we got out of the place?

Q No. I think that would be sufficient.

A We got out through the Colonial Room, and the Colonial Room faces -- we were walking out this way, and then I made a right turn and I went out through two more doors.

And I remember that -- these doors because there was a red carpet and -- there was a red carpet.

I made a left turn to some -- it's a big lobby; I remember the two pillars on the side, the corner pillar, and there was the other pillar which cause a little passageway.

There was people all the way through from the time we were taking the suspect out, the people hollering, "That's him. That's him. Kill him. Kill him. That's him. He did it." That's him.

That's why you moved as quick as you did? Q

Yes, sir.

MR. HOWARD: Fine. Would you return to the stand? (Whereupon the witness complied.)

MR. HOWARD: That's all we have unless there is a question from the Jury.

THE WITNESS: I am the Assistant Maitre d'at the Ambassador Hotel in the Banquet Department.

A He got loose of my hand again and shook

hands again with one of the dishwashers.

And then I took his hand again, and while I was pulling him, I was trying to get -- because too many people came behind us at that time.

Mr. Uno was in front of us -- Mr. Timanson -- and he was calling, waving over, and I was trying to get as fast through the kitchen area there, through the pantry, as I could.

And while I was holding his hand, I was turning to my right towards -- to the Colonial Room where the press room was.

At the time something rushed on my right side. I -- at that time I didn't recognize what it was, and I saw some paper flying. I don't even remember what it was, paper or white pieces of things.

Then I heard the first shot and the second shot right after that, and Mr. Kennedy fall out of my hand. I lost his hand.

I looked for him, and I saw him falling down.

And I turned around again, and I saw the man
right standing next to me.

The arm, was holding the gun in, push the arm down on towards the steam heater, and my right arm I

took around his neck as tight as I could, and pressing him against the steam heater.

In the meantime, somebody else came behind me and pushed me against the steam heater. The guy in front of me couldn't get loose.

While I was holding the hand where he had the gun in, I was trying to get the point of the gun as far as I could away from the part where Mr. Kennedy was laying.

From the left side, I was trying to push the gun away to the right side where I didn't see too many people, while he was still shooting.

Q Up to that point, do you remember how many shots you heard?

A I couldn't heard too clearly, but I thought it was five or six, but I was hitting his hand on the steam heater as hard as I could, with my left hand, I had him right here on the wrist, and hitting my left hand on the heater to get rid of the gun.

- Q He has his gun in his right hand?
- A In his right hand, yes.
- Q And you grabbed him with your left hand?
- A The left hand, yes, and had the right arm around his neck.

I was standing there and he was shooting, and I could feel when he was turning his hand towards the

And then I saw some hands coming over, 1 reaching for the gun. I don't know who it was. 2 . 8 In the meantime, in between, I looked over my left shoulder and saw my partner, Eddie Minasian, and hollered to him, "Get the police, get the police." I saw him running off, taking off through the people. They were standing on the left side. About how many shots did you hear altogether? 10 I couldn't swear on it, but I think it was there was six shots -- six -- could be seven. 11 12 While I was hitting his hand on the steam heater, there was noise, too, you know. 13 14 Before you grabbed his arm or his hand with Q the gun, had the gun been shot before that? 15 16 Yes. 17 Q About how many times did that gun go off 18 before that? 19 A Twice. 20 Q Twice that you know? 21 I must have grabbed the arm by the third 22 shot. 23 Now, were you just going to escort Senator Kennedy through the kitchen to some other place? 24 25 Yes, towards the Colonial Room, which is -supposed to be right here behind this here (indicating). 2€

Q The Colonial Room --The news room, right here. That would be to the east of the pantry where you were, is that correct? Right, yes. You were passing him through when the shooting took place? 7 Through there, yes. You see the exhibit there in front of you 9 which has been marked Grand Jury Exhibits 3-A and 3-B, sir? 10 A Yes. 11 12 Q Is that the man --Yes. 13 14 Q -- you grabbed? 15 A Definitely is. 16 Q He is the one that was doing the shooting? 17 Right. 18 I show you what has been marked Grand Jury 19 Exhibit 2-A. Do you recognize anybody in that photograph? 20 Yes. Mr. Uno Timanson, here on the left --21 he was not standing there before. He was standing farther 22 towards the Colonial Room, or to the east. 23 He must have come, run over here towards --24 to see. And do you see yourself in that photograph? Q Yes. I'm right here. 26

And someone has already put your name on, Q where you are, is that right? Right, yes. And there is someone against the table there on the table with a number of people grabbing towards what 5 appears to be an arm or a hand there, is that right? That's right. 7 It's what I said before, I was holding on to him, and people were trying to get hold of the gum, right 9 Okay. That is the gun that everyone is Q 10 reaching for then in that photograph? 11 Right. 12 I will show you the gun that has been marked 13 Grand Jury Exhibit Number 7. 14 How does this compare with the gun that 15 this person, pictured in these photographs, 3-A and 3-B, 16 17 had? I don't know too much about guns, but I 18 think it was about this size. It wasn't bigger than 19 that (indicating). 20 Did it look like that gum as far as you 21 Q can tell? 22 I think so. Yes, it was not bigger. The 23 gun was not bigger than this one. 24 I understand, you can't say it's the same Q 25

gun?

I couldn't tell you it was the same gun because I was too busy to keep him in my headlock. Did you find out or did you see other Q people that were shot or injured besides Senator Kennedy? Yes. While I was holding the right arm from the shooter, I looked to the left, and while he was shooting still, I saw some more people falling down. But I wasn't sure they were shot or they just bent down to get away from the -- from the shots. Q After the shooting stopped --I couldn't tell you. After the shooting stopped completely, did Q you see some other people bleeding or injured besides Senator Kennedy? No, I did not. MR. FUKUTO: That's all I have. THE FOREMAN: Mrs. Meyers has a question. Q BY MR. FUKUTO: How far was the suspect -by "suspect," I mean the person that you finally caught pictured in those photographs that you identified -- how far was the suspect at the time -- start over. How far was the suspect from Senator Kennedy and yourself at the time that the first shot took

because I remember I was trying to pull him, and the man who shot, I could feel him coming around me and falling over the steam table and start shooting. You indicated that you had Senator Kennedy in your left hand? Right. You had his right hand with your left hand? Right. And you were directing him across the pantry toward the Colonial Room, is that right? 10 Right. 11 And you indicated something rushed past you. 12 Was that a person that rushed past you? 13 A On the right side? 14 Q Yes. 15 Yes, it was the one who shot. 16 Okay. He rushed right past you and did he 17 Q reach over you at the time he shot? 18 He reached over in front of me. 19 And he reached over from --20 0 Not over me. He just -- I could feel when 21 he -- I was right close to the steam table when we pass 22 through, and I guess I could feel that the gun was about 23 this far, when he shot, right from me, from my right. 24 Your body was in between this person's 25

body and --

-- and Senator Kennedy. And his arm reached over your body when he fired --Around me, around me, not over me. MR. FUKUTO: Around you. Any other questions? Was there a previous arrangement for you to escort Senator Kennedy to the Colonial Room? No. As much as I know, he was supposed to -- the first plan was that he was supposed to go 10 downstairs, the next floor, the next ballroom where we 11 had the -- the other people which couldn't come into the 12 Embassy Ballroom. 13 And we had about fifteen or eighteen hundred 14 people in there, and he was supposed to make a speech over 15 16 there. And their minds were changed at the last --17 the last minute. 18 When I came out, I just remember that 19 somebody told me, 'Turn to your right. Bring towards the 20 Colonial Room." 21 Someone told you to do that? 22 Q Yes, somebody told me. I think it was Mr. 23 Uno Timanson. 25 Did you notice this person before this Q

shooting took place --

A Not at all.

Q -- the suspect?

A There was nobody on my right side in front of -- my right side toward the Colonial Room. I couldn't see anybody there except --

Q Did you notice anybody else other than hotel employees inside the area there?

A No, just behind the -- the door, which goes into the pantry, I think somebody was on the right side.

I think it was somebody from the newspaper or -- but I couldn't tell you.

Q Mr. Minasian, what is your business or occupation?

A I am employed by the Ambassador Hotel.

A As a banquet captain. Directing your attention, if I may -- the Ambassador Hotel is located on Wilshire Boulevard, is that correct, sir? 3400 Wilshire Boulevard. And were you working in or about the 13 Q Embassy Room? 15 Yes, I was. 16 Was there some type of Kennedy sponsored party at that location? 17 18 Yes, there was. 19 Was there a great number of people? 20 Yes, sir. 21 At about midnight or shortly thereafter, did Senator Kennedy arrive, to your knowledge, to give a 22 talk or speech to his supporters? 23 24 Yes, he did. 25 And did he give a talk from a little 26 platform?

Were you detailed to go with him upon completion 18 19 of the speech? 20 Yes, sir. Did you know where the Senator was going? 21 Well, we had -- it was discussed upstairs 22 that when the Senator finished, that we were going to go 23 down to the Ambassador Ballroom, which is one floor below 24 us, where there were additional precinct workers. 25

Was there a second party on that level? Yes, sir, because of -- the fire inspectors Q 1 were there and they told everyone that the number of 2 people were going to be limited into the Embassy Room. 3 So consequently, they also made arrangements to have the Ambassador Ballroom available for additional people, and the Senator --That's fine. Pardon me. I didn't mean to Q 8 Was there a change of plans at the last interrupt. 10 minute? Yes, sir. 11 Were you directed to escort the Senator 12 Q 13 somewhere else? 14 Yes, sir. Where was that, sir? To the working news room, which was called --15 Q 16 at that hotel it's the Colonial Room, but they changed 17 it into a working press room. 18 Going to that diagram, would you take the 19 20 marker --THE FOREMAN: Right here. 21 BY MR. HOWARD: -- which is hanging -- will 22 you describe on that to us what happened when the Senator 23 left? Did you start out through a back --24 Well, we came in through here and he made 25 26

the speech, and there were some curtains drawn here and the stage was extended out, and I was led to believe that -- and understand we were going to go out this door and we were going to turn left, to go down.

Instead, it seemed to me there was a suggestion with several other people about going into the news room for an interview. Because of the lateness of the hour, they wanted to get some film back to -- to the East.

So the last minute -- it couldn't have lasted more than ten seconds or so -- decided to turn right -- the whole party, the Kennedy party decided to go to the Colonial Room at this time.

And we proceeded through this area -THE FOREMAN: Can you speak just a little louder?
THE WITNESS: Yes. Shall I continue?

Q BY MR. HOWARD: Real loud, please.
You went through a door we have designated
as S-2?

A Right.

Q The party did. You proceeded then down toward the area that is marked Serving Kitchen on the diagram; is that a fair statement?

A That's correct, sir.

Q Did something happen in this general area?

A Yes, sir.

I was walking, possibly no more than two feet in front of the Senator, on his right-hand side, and Karl Uecker was approximately in the same distance on the left-hand side of the Senator.

And as we were walking forward, and just as we reached the serving table section here, the steam tables, on the Senator's left there was several hotel employees standing in this area, and the Senator noticed them and he stopped to shake hands.

He turned to his left, and I proceeded to take an extra step or two, and I felt that he wasn't as close as I -- as he was when we started walking.

And I turned my head to the left again, and I took a step back towards him to stay a little closer to him -- and Karl Uecker did the same thing -- and it seemed to me just at that precise moment that I turned to my left, out of the side vision, my peripheral vision, I noticed someone dart out from this area, dart out and lean against the steam table.

And I saw a hand extended with a revolver, and I saw the explosion of the cartridges out of the -- out of a revolver.

It was a bang-bang cadence, and after the second shot, why, as I said, I saw the flash of the cartridges being discharged, and immediately there were several other people in that area behind the Senator, and I just pushed into Karl Uecker.

And he -- we both made an attempt to get at the hand holding the gun, and we had him -- I was down low, pushing up against him.

And at that same time I turned to my left and I saw -- well, there were some more wild type firing which was a more rapid fire than the first two, as they were struggling for the gun. I'm sure that's why the gun was going off.

And it seemed to me that the gentleman standing behind the Senator fell first.

And the Senator was kind of staggering a little bit, and then seemed to me that that was the order that they fell.

Q How many shots were fired in all, can you tell us?

A Well, I -- at the time that I was questioned, I thought there were approximately six.

I thought he emptied the revolver, and there were quite a few -- I know the first two were deliberate, and the others came in quick spurts, so --

Q Were the first two or the first series,

we will call them -- if there were two -- was that before 1 anyone touched the suspect or the person shooting? Yes, sir. After that, people started grabbing? Right. And there were then shots fired after that, is that correct? That's correct. Were those shots fired in the general direction of the Senator? 10 11 I doubt it because the Senator at that time 12 was -- well, the suspect was shooting from this -approximately this point (indicating). 13 That's the end of the --15 At the end of the table. 16 And when the Senator fell, he fell in this 17 area right here (indicating), on an angle. 18 And I don't see how he could have been 19 shooting at -- and we had him and his arm was somewhere on this steam table here. 21 And I doubt if it was in the same direction as the first two shots. 22 23 Now, would you return to your seat, 24 please? 25 Before we go further, let's see ifwe can find something out. Maybe you better stay there a moment. 26

On this diagram, you'll notice in the area located as Serving Kitchen, there appears to be what I would describe as three serving tables, is that correct?

A There was a great deal of confusion.

Everybody was trying to do something.

And surprisingly, the only thing that -- around the Senator, no one was near the Senator after he had fallen, I would say, for -- approximately a minute elapsed before anyone got near the Senator.

And the television -- as I said, there were a great deal of cameramen with the portable television cameras that were following the Senator. I would say there might have been approximately thirty, thirty-five people walking directly behind him with cameras and lights, and so on.

And when this happened, everybody just kind of caused a great mayhem (sic) back there, and I saw -- noticed several newsreel people pushing everybody back into the -- in the direction of the Embassy Room.

The doors which we entered the pantry, there were several people pushing people back through the same doors that we entered.

MR. HOWARD: That's all we have of the witness.

THE FOREMAN: Any questions? Do you have any
questions? Mrs. McCowan has a question.

Q BY MR. HOWARD: If you know, at the time that the Senator completed his speech, who, exactly, was responsible or gave the direct order that the route was changed from going downstairs and going instead to a press conference in the Colonial Room?

A I have no idea.

All I heard -- in that particular area, it's -- the visibility is not too clear. It was dark.

And again, it was just to the -- I would say about five feet to the left of that door was the anchor desk where Pierre Salinger and Mr. Mankiewicz were sitting there, getting returns on the phone, and so forth.

There were a great deal of people up there and I can't positively identify anyone who decided to go to the press room.

But would it be a fair statement that Q you, at least, knew of that as you left what we have demonstrated to be there as the stage? To go to the Colonial Room? Right. Yes, sir. As I understand you, this is, now, by the diagram, as you left -- on Exhibit 1 -- the door on the upper area over the words "Stage Anteroom," you expected to turn left? 10 That's correct. 11 Had you turned left, you would have gone 12 downstairs to the second party? 13 That's correct. 14 Instead, you turned right on a path toward 15 the Colonial Room which would be off the map through the 16 17 serving kitchen; fair statement? That's correct, sir. 18 And you did not know that until some time 19 after you started out, actually? 20 That's correct. 21 And there appeared to be some type of 22 consultation? 23 That's correct. 24 Now, if you know, that consultation took 25 place near a desk where, at least to your knowledge, where

26

there were people at that desk?

A It wasn't done at the desk. It was done while they were standing at that -- right at that doorway.

But due to the location of that desk -there were a great many people there -- so I couldn't
positively identify who decided to --

Q -- who was in on the conversation. Do you recall that?

Yes, it was difficult to.

THE FOREMAN: No further questions? There being no further questions --

EXAMINATION BY MR. HOWARD: Is that B-u-r-b-a, last name? Yes, sir. What is your business or occupation? Fireman, City of Los Angeles, Fire Department. Do you have a special assignment as a Q Fireman? I am assigned to the Photo Bureau. 10 And as part of your duties, do you cover 11 different events and take photographs as necessitated by 12 fire prevention -- or for proper fire prevention? 13 14 When requested by other agencies such as 15 the Fire Prevention Bureau, yes. And by "overcrowded," what are we talking about, in the neighborhood of hundreds of people, thousands? What are we talking about? A rough estimate would be a thousand people. Now, at the time you saw the Senator, you were not in the Embassy Room itself, is that correct? 10 No, sir. 11 Where were you? Q 12 What has since been referred to as the 13 kitchen. It was a little, oh, alcove where the kitchen 14 help ate, apparently. There were tables and chairs. 15 After you saw the Senator enter and Q 16 apparently disappear for a speech, did you see him shortly 17 thereafter? 18 I -- I didn't see him before the shooting. 19 I -- I saw the party come back that way. I didn't 20 actually see the Senator. 21 Could you tell, by the flow of people --22 Yes, sir. 23 -- that the Senator was in the party? 24 I -- I could tell from the flow that he 25

was coming back out, and I couldn't place exactly where

the Senator was. 1 Now, did you see or hear some shots? 2 I heard shots. Where were you at that time? Q I was sitting in the -- in this little alcove back in the corner. Is that a little area where there are Q tables, where people that work there have their meals? I presumed that was the purpose of it 9 because several people had come in, sat down, and had 10 coffee and a piece of pie, or something. 11 And it appeared to be like picnic tables Q 12 there? 13 There was, I believe, only one or two 14 tables there. 15 What is the first thing that you noticed Q 16 or heard that was unusual? 17 I think the first thing that attracted my attention was the gunshots sounded like a cap pistol to me. 18 19 What did you do when you heard those shots? 20 Well, I was looking in that direction and 21 saw the flashes, and I jumped up and started over in that 22 direction. And there was such a big crowd around, that 23 I -- my second thought was, "My job is to take pictures," 24 so I went back and got my camera and started taking 25 26

pictures. Did you go to the scene and take pictures? Yes, sir. A At the time you arrived and shot your first picture, will you describe the area that you shot in your 5 first picture? Well, it was hard to get close. I couldn't 7 see the Senator himself. But I did see some struggling, so I just snapped a picture in that general direction, not -- not 10 knowing what I was shooting. 11 May I direct your attention to a photograph 12 that we have previously identified as Grand Jury Exhibit 13 2-A. Will you examine that? 14 Are you familiar with that photograph? 15 Yes, sir. 16 Did you take that photograph? Q 17 Yes, sir. 18 Now, as a sequence of shots, would you have 19 any way of knowing if that was the first of the sequence 20 of shots that you made, or a present recollection or 21 **2**2 belief? I believe it was. And the only way I could 23 be sure is to look at my negatives. 24 Now, directing your attention to this Q 25 picture, when you shot it, what kind of a camera did you

use? 1 A Rolleiflex. 2 Is this an enlargement of what you actually Q shot? This is a crop. The Rolleiflex uses a 5 square picture, and this is the -- a blowup of the 6 principal action. In other words, it fairly portrays what --Q 8 the picture you shot, but it's been enlarged for clarity? Yes, sir. 10 And at the time that you shot this picture, Q 11 time-wise, how long had the shots preceded your shooting 12 this picture? Are we talking --13 I would estimate roughly thirty seconds. 14 Now, there is an individual there who Q 15 appears only by what appears to be bushy hair, is that 16 correct? Is that a fair statement? 17 Are you referring to the head we see here? 18 Right. Q 19 Yes, sir. A 20 It appears that people are holding a person Q 21 Yes, sir. 22 A -- and we see a head, is that correct? Q 23 Yes, sir. 24 When you shot that picture, or shortly 25 thereafter, did you get a better view of the situation 26

than in that picture? No, sir. Did you ever see the person that was held down in the area of the head in the picture, 2-A? Not after the shooting, no, sir. Q Did you see someone removed by the police? I -- no, sir, I didn't see that action. You shot the series of pictures though, did you not? 10 Yes, sir. 11 I'd like to direct your attention to the photographs we have marked the 3 series, A and B, now 12 before you. Will you examine that person? 14 A Yes, sir. 15 Have you seen 3-A and 3-B? Now, you told 16 us that you were in -- can I refer to it as the kitchen 17 area of the Embassy Room? 18 Yes, sir. 19 -- for at least a half an hour before the 20 Senator arrived? 21 **2**2 Did you happen to see that individual depicted in the picture? 23 24 At the best of my knowledge, this person followed the Senator in when he arrived, and I couldn't 25 say how far back. 26

But he was in the group that walked in with the Senator. Q Now, how were you dressed that night? Much the same as I am now, except I had short sleeves and no tie. Q But you were in a uniform distinctive to the Fire Department? 7 Yes, sir, yes, sir. And you, as you looked around, recalling now, were you perhaps one of the few people there in a 10 uniform? 11 12 Probably the only one. Did you have a badge on, similar to the one 13 you wear now, over the heart? 14 15 The identical badge, yes. 16 As this person walked in, depicted in the 17 exhibit before you, Exhibit 3-A and 3-B, is there some reason that you observed him in the party? 18 19 Yes, sir. He appeared to be looking all 20 around him instead of looking ahead, as all the other 21 members were, and --When he passed you or got near you, was Q 22 there anything that you noticed? 23 He -- well, he seemed to look at me as he 24 passed by. 25

But then he looked on around, but he was

looking all over all the areas as he passed by. So I will understand, the Senator was entering to make his speech? Yes, sir. I assume a crowd came with him? Q Not too big a crowd. What are we talking about, twelve, twenty --Q what? Not over ten or twelve people, I would say, offhand. 10 It's hard to judge because there were other 11 12 newsreel photographers and television men, and so forth, that I don't know whether they were in the party or not. 13 Right. But you, when we say party, you mean 14 the Senator's party? 15 As far as I know, there were only about ten 16 17 people in the party. In addition to the ten, were there Q 18 newspaper photographers or television cameramen, too, that 19 you do not consider as part of the party, but that were 20 there? 21 There were a few. It -- it was as if they 22 didn't really know he was coming -- this route or at this 23 time. They didn't seem to be prepared. 24

There was only possibly one television

cameraman, but there were other men running back and forth

25

in conjunction with this cameraman.

Q Now, the person depicted in 3-A and -B, did he follow the Senator out of your view?

A The last -- the last I saw of him, he reached the intersection -- as I picture it in my mind, it's really one corridor that they entered, and it intersected this other corridor which runs parallel to the ballroom.

He had an object in his hand as he passed by, and I saw that object in the air, later, up at that -the intersection of these two corridors.

Q You mean later, at the time of the shooting, perhaps?

A No, possibly, oh, just after he had disappeared from view.

But I noted this as he passed by, and then I noted it again up in the air, and I assumed it was the same person.

The only reason it caught my eye was because it was the same object. I wondered about it as he passed by, what it was.

Q When the person passed by, he had something in his hand, or hands?

A Yes, sir.

Q Could you describe that to us?

A Well, it looked to me like a rolled up

poster, and I thought maybe it was a Kennedy poster, or something.

And he was holding it in both hands.

He had just one box aside from all these other -- that it's called the mini-magnum; and this type of bullet, when it penetrates on an object, usually tears and splits out into different directions where the regular bullet of a .22 caliber goes in a hole, and when it goes into an object, it will come out the same size.

And he was -- he asked him the reason for this, and he didn't know what the reason for his -- I

Q 13 No, sir. 14 Did you take the spent cartridge casings out Q 15 of the gun? 16 I took one out to identify the exact caliber-A 17 and replaced it. 18 What did you do with the gun then? 19 I retained it in my possession until 20 approximately 10:00 a.m. that same day and booked it into 21 evidence at Central Property, Los Angeles Police Department. 22 Did you later determine that it was 23 released to someone for scientific tests? 24 Yes, sir. 25 To whom? DE WAYNE A. WOLFER,

called as a witness before the Grand Jury, was duly sworn as follows:

(Whereupon the witness raised his right hand to be sworn.)

THE FOREMAN: Do you solemnly swear that the evidence you shall give in this matter now pending before the Grand Jury of the County of Los Angeles shall be the truth, the whole truth, and nothing but the truth, so help you God?

THE WITNESS: I do.

THE FOREMAN: Would you be seated, please.

EXAMINATION

BY MR. FUKUTO:

Q Would you state your name, for the record?

A Yes. It's DeWayne A. Wolfer. That's

D-e W-a-y-n-e W-o-l-f-e-r.

Q What is your business or occupation?

A I am a police officer for the City of Los
Angeles, assigned to the Scientific Investigation Division,
Crime Laboratory, where I act as a criminalist, and among
my criminalistic duties is that of firearms and ballistics
expert.

Q Would you tell us your training and qualifications with respect to your duties as a criminalist and firearms and identification expert?

A In the way of normal education, I have my Bachelor Degree from the University of Southern California where I was a pre-med student, and have a background in the field of chemistry, physics, and all types of laboratory technique courses.

In the way of practical education, since my assignment to the Scientific Laboratory in January 1951,

I have traveled throughout the United States to all of the major firearms factories where I have made studies and worked in these factories, what we call forensic ballistics.

By "forensic ballistics" we mean the study that would be used in a court of law.

In these factories I have manufactured barrels and all parts of guns to study the basis of -- upon which we make our identifications.

Some of the factories where I conducted

these studies would include those such as Remington, Winchester, Hi Standard, Colt, Smith and Wesson, Iver Johnson, Harrington and Richardson, Great Western, and others.

I have made similar and like studies at all of the major ammunition factories, which we include Winchester, Western, and Federal, and Remington-Peters.

I have made the same basic studies here.

I have worked in ballistics laboratories. I manufactured ammunition to study all phases that we would use in courts of law.

I have worked at the major powder manufacturers. Some of these trade names would include Hercules and Du Pont, and such as this.

I am presently an assistant professor on a part-time basis at the California State College at Long Beach where I offer a year and a half's course in the fields of criminalistics, of which firearms and ballistics is a portion thereof.

In addition to my part-time teaching there, and I have taught on the campuses -- I have taught the criminalistics subject matter on the campuses of U.S.C., of El Camino College, Fullerton College, Santa Barbara College, Ventura College; during the summer sessions under the auspices of the State Board of Education, I have taught on the campuses of Cal, U.C.L.A., and California

I have testified hundreds of times involving State College at L.A. firearms and ballistics matter in our courts here in the State of California such as our Municipal, Superior, and Federal Court Systems.

I have testified in at least five other states on numerous occasions involving these firearms and ballistics matters.

I have given -- published papers regarding

How long have you been a firearms expert the matters. with the Police Department?

Since January 1951.

Is it possible to read markings on a bullet that is fired from a gun and determine what gum that bullet was fired from?

Yes, it is.

How is that done? Q

Basically, it would be such that in the barrels or the rifling of the weapon there is what we call imperfections which scratch the bullet as they cross these imperfections.

These imperfections produce in the bullet a series of valleys and ridges which we call striation marks in this particular field.

We would take and fire the gun into a water

recovery tank so that the bullet entered the water and was stopped with little or no damage.

We would then recover that bullet and place it under what we call a comparison microscope, which is simply two microscopes with one eye piece.

We place the bullet that we test fire through the suspected weapon on one stage of the microscope and the bullet, such as the -- such as a Coroner's bullet or the evidence bullet on the other stage of the microscope.

Then as we look through the common eye piece at both of these bullets, we would be able to see lines on one bullet, on one side of the microscope, and lines on the other.

We would try to line them up as our fingers (indicating), and if we can line up a majority of the lines, we can say it was fired from this revolver and no other.

Q Have you looked at Grand Jury Exhibit
Number 5-A?

A I have.

Q And when did you first see that exhibit?

A I first saw this exhibit at approximately -oh, I would estimate somewhere in the latter afternoon
between, oh, I'd say 2:30, 3:30 yesterday afternoon.
